## A BILL

2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INDIVIDUAL INCOME TAX RATES FOR CAPITAL**  
4 **GAINS AND DIVIDENDS MADE PERMANENT.**

5 Section 303 of the Jobs and Growth Tax Relief Rec-  
6 onciliation Act of 2003 is amended—

7 (1) by striking “this title” and inserting “sec-  
8 tion 302”, and

- 1 (2) in the heading, by striking “**TITLE**” and in-
- 2 serting “**SECTION 302**”.
